The adult outpatient clinic services a wide variety of patients from East Los Angeles and surrounding communities. The office works as consultants to the Consultation and Liaison Services who provide psychiatric consultation for medical patients on the inpatient unit, in outpatient facilities and in the prison ward of the General Hospital. The primary task for Psychology Clerks consists of designing appropriate test batteries considering the referral question(s), patient's intelligence level, reading ability, cultural background, and location of the patient. A clinical interview and initial screening measures are administered to further clarify the appropriateness of certain measures, a final test battery is agreed upon and the patient is administered the tests. Ultimately, a full psychological report is issued to the attending physician that includes patient's

background history, behavioral observations, test results and a summary and recommendations for treatment. The fifteen hour per week commitment includes the before mentioned assessment procedures, individual and group supervision, report writing, biweekly multi-disciplinary case consultation meetings with psychiatrists and psychiatry residents and weekly training seminars with topics including a variety of assessment procedures and assessment with varying population.
